BARLOW TRAIL CLOSURE – AIRPORT TUNNEL UPDATE

In March, 2011, access from the South to Calgary's Airport via Barlow Trail will be eliminated. To make way for their new north/south runway, the Airport Authority is closing both Barlow Trail and McCall Way north of McKnight Boulevard. During deliberations on Calgary's Plan It document, we succeeded in getting the tunnel underneath the new runway back into the City's transportation plan (see Plan It Update below) but our work is not done yet. We need input from Ward 3 residents and time is of the essence. The Airport Tunnel Action Committee (ATAC) - www.yestunnel.com - have scheduled a Town Hall Meeting for Monday, November 9th, 7:00 p.m. at the Sheraton Cavalier Hotel Ballroom, 2620 – 32 Avenue NE. Come out, get an update on what's been happening and make your voice heard on this important issue!

PEDESTRIAN CORRIDOR

The Transportation Department has advised that a flashing pedestrian corridor will be installed at the intersection of 64th Avenue & Martingrove Drive NE. Work on the infrastructure required will begin right away. It is anticipated that installation of the flashing lights will be within the next 3 to 4 months.

PLAN IT CALGARY UPDATE

At the 2009 September 28th meeting, Council adopted, as amended, the Municipal Development Plan (MDP) and the Calgary Transportation Plan (CTP). There is a link to these documents, along with all the amendments made by Council on the Ward 3 website at www.ward3calgary.ca. Initially Administration had removed the Airport Trail tunnel from the Transportation Plan, but Council supported my amendment to have it reinstated. As well, I was supported by Council to retain Airport Trail and Metis Trail as skeletal roads (previously called "expressways"). The proposal by Administration was to have both of these roadways downgraded to arterial roads (previously called "majors").

The North Central LRT line alignment was approved as well. I noted inconsistencies to the alignment presented by Administration in the CTP and adjustments have been made. When a map showing the correct alignment is available, I will post it to the Ward 3 website.

CALGARY TRANSIT SAFETY SURVEY

Calgary Transit has completed a safety, security and cleanliness survey of 500 regular Transit users (customers who use Transit more than once per week). The survey, by independent research group HarCorp Management Consultants, shows improvement in all areas compared to the same survey completed in 2008. Survey statistics show that crime on Calgary Transit property has decreased significantly in all areas including property crime, vehicle theft and vandalism. Proactive patrols by peace officers have reduced demand on the Calgary Police Service by 20%. Safety initiatives such as the Mountain Bike Peace Officer Team and enhancements to Calgary Transit's surveillance camera system have been implemented and are proving very effective.

2009 LEAF & PUMPKIN COMPOSTING PROGRAM - DROP-OFF DEPOTS

I encourage you to take advantage of the City's drop-off depots for bagged leaves and pumpkins again this Fall. There are 34 locations throughout the City, including the landfills, where you can drop off your bagged leaves and pumpkins at no charge from October 3 through November 8. You can get information on drop-off depot locations by calling 3-1-1 or by visiting the Ward 3 website at www.ward3calgary.ca. Waste & Recycling Services asks that whenever possible, you use paper yard waste bags as these bags can go directly into the compost pile, increasing the efficiency of this composting program. Remember, this composting program is for leaves and pumpkins only and does not include other yard waste such as branches or pruning materials.
